What is the Weatherization Assistance Program (WAP)?

<u>FUNDING</u>: The Weatherization Program is sponsored by the US Department of Energy and by the ADECA – Energy Division and administered by the Central Alabama Regional Planning and Development Commission (CARPDC).

<u>PURPOSE</u>: The program's purpose is to improve the energy efficiency of the residence and <u>does NOT perform rehab or</u> <u>remodeling work</u>. It assists low-income families: 1) primarily the elderly, 2) persons with disabilities, and 3) families with children (18 and under) to reduce energy costs. This program is free to <u>eligible home</u> <u>owners</u>.

1. How does the Weatherization Program work?

Prospective applicants fill-out a simple onepage application (see reverse) and provide the following documents:

Proof of income (i.e. <u>pay stubs, Social</u> <u>Security, retirement or pension for ALL</u> <u>occupants.</u>)

Proof of property ownership (i.e. <u>copy of</u> <u>deed or property tax notification</u>)

Proof of residency (i.e. <u>copy of energy bills</u>, <u>electric and gas</u>) these documents must have the name and address of home owner.

Identification (copy of <u>driver's license and</u> <u>social security card</u> for <u>each</u> occupant)

Property Report Card – (from Court house or tax assessor's office, N/A for Mobile Homes)

Application will be reviewed for income and family eligibility.

- Assessment of the property will identify the weatherization needs of the residence.
- If your application is approved, CARPDC contractors will review and bid on the weatherization work at your home.
- A contractor will be selected and assigned to perform the work on your home.
- Upon completion, work will be inspected for quality and compliance to program standards.
- If work requires redoing, the contractor will complete the rework in a timely manner.
- Upon completion of the weatherization process, you will start enjoying a more comfortable and energy efficient home.
- 2. If you are a renter, can the Weatherization Assistance Program assist you?

The answer to this question is yes. The process is similar to the one just described. The difference is an additional step in the process. The owner of the property, your **landlord**:

1) will be asked to pay a portion of the costs of the measures installed on your home, and

2) **required** to not increase the rent for one year from the date of final inspection.

If you are a renter, pass this information on to your landlord. The program will be beneficial to the both of you.
